Juror:

This year's juror, Stephen Horne of Paul Smiths, NY, has had a career as an illustrator, editorial cartoonist, painter and museum exhibit designer, after training at Colgate University and graduate work at the Boston University School of Fine and Applied Arts. During his time as the Artist-Designer for the Adirondack Park Agency, where he assisted in the development of the Visitor Interpretive Centers in Paul Smiths and Newcomb, NY, Horne was a frequent juror for regional exhibitions, serving twice each for the annual Adirondack Life and Arts Council of the Northern Adirondacks juried exhibits, both at the Lake Placid Center for the Arts, as well as twice as juror for exhibits at the Adirondack Lakes Center for the Arts in Blue Mt. Lake and the Adirondack Artists Guild in Saranac Lake. His paintings were most recently exhibited in "Imagined Landscapes," a four-person show this spring at the Lake Placid

Center for the Arts. Horne is a member of the Oil Painters of America and the National Oil and Acrylic Painters Society.

Eligibility:

Open to all artists, 18 years or older, living within a 100-mile radius of Ogdensburg, NY. Work must have been made within the last two years.

Requirements:

\$10 members/\$20 non-members for up to three digital images entered.

All entries must be initially presented as digital images posted through the form at fredericremington.org or emailed to lafo@fredericremington.org or on CD, in jpg or tiff format, accompanied by completed entry form and payment.

Media/size: Artworks in all media are accepted. Flat works are limited to 36”w x 72”h including frame; sculpture may not exceed 60”h x 24”w x 24”d.

Accepted art must be finished and ready for exhibition – no wet work, no assemblage needed – and able to withstand regular handling.

2D work must be framed or otherwise ready to hang. Works on paper must be framed and protected with glass or plexi. The museum reserves the right to modify hanging hardware.

Hand delivery of accepted art is preferred. Art may be shipped to the museum, but it must be in a reusable container, and must be accompanied by payment for return shipping. Art and its packaging should be able to withstand the rigors of the chosen shipping method.

Accepted art must remain for the duration of the exhibit. Artwork that has not been picked up by February 20 becomes the property of the Frederic Remington Art Museum.

Art in the exhibition may be for sale. One third of the sale price will benefit the Frederic Remington Art Museum.
