Release Waiver. Please sign to indicate your agreement to each of the following:

1. I understand that participating in the Color Me Remington 5K Fun Walk/Run is a potentially hazardous activity where powdered color will be thrown at and around me during the course of the event. I acknowledge I am being given sunglasses to protect my eye during the event.
2. I agree not to participate unless I am medically and physically able, which I am solely responsible to determine.
3. I assume all risks associated with competing in **Color Me Remington 5K Fun Walk/Run**, including, but not limited to, slips, falls, contact with other participants, negligent or wanton acts of other participants, any defects or condition of premises, or color zones, the effects of the weather including high heat, cold temperatures, storms and/or humidity. All such risks being known assumed and appreciated by me.
4. I consent to emergency medical care, transportation and all related costs of such in the event of injury to me at this event.
5. I grant permission to the **Frederic Remington Art Museum** to use any photographs, motion pictures, recordings or any other record of this event.
6. I understand that all entries are final with no refunds. The official race directors reserve the right in any event of emergency to cancel the race and understand there is no refund of entry fees.
